

Restitution—students are expected to pay for or repair deliberate damage or loss of an item.

Dress Code (Grade 7-8)—Lansdowne school has an informal dress code which applies to all students in the building: strapless, bikini or off the shoulder tops are not permitted, midriffs and navels should be covered and shorts or short skirts should reach mid thigh. Heels on shoes should be an appropriate height to allow students to participate safely in all classroom activities. Please remember that sometimes teachers will teach lessons outside or in another room such as the gym or library. For theatre class, students' clothing and footwear should not restrict their movement.

In-school suspension—student will work in a designated area away from other students for one to three days. Parents will be notified.

Suspension—suspension from school is a serious consequence which is imposed subject to Division Policy JGD. It may occur as a result of repeated non-compliance or inability to conform to school rules. The maximum single suspension is as follows:

- A) Principal—up to one week. More than one week requires Superintendent's approval.
- B) Superintendent—up to six weeks. In all cases of suspension, the parent(s)/guardian(s) are notified.

Expulsion—in accordance with School Division Policy. This measure will be recommended only in extreme circumstances or after all other attempts at intervention have proven unsuccessful in changing behaviour.

Students should go directly home at dismissal times unless previous arrangements have been made with parents/guardians. Those students who wish to play on the playground after school should first report to home or sitters.

Lates & Absences

- Parents/Guardians must call the school if a student will be late/absent or must send a note to inform the school of the absence or lateness. The agenda book may be used for this purpose.
- Should the school not receive notification of an absence the parent/guardian will be called by the school to ensure the student is safe.
- Students who arrive late must report to the office to indicate their arrival.
- Students who need to leave the school early (i.e. dentist appointment) are required to bring a note from their parent to the teacher. Parents have to come to the office to sign out the student.
- Parents must call the school by 2:00 p.m. to advise if a child is not to take the school bus home.

If for any medical reason a child cannot go out for recess for an extended period of time, a note from the doctor should be sent to the school with notification of the health problem.

Parent Run Lunch Program

Lunchroom students are expected to:

- treat all students and adult supervisors with respect.
- use proper table manners.
- remain seated until dismissal.
- stop talking when the lights are turned off.
- eat at the school unless they have written permission from their parent to leave.

When a student does not follow lunch program responsibilities, parents/guardians will be notified in writing by the lunch program coordinator.

Positive Behaviour at Lansdowne

At École Lansdowne School children will be made aware of the school and the division Codes of Conduct. Parents/Guardians are encouraged to discuss these codes with their child/ren to help create and maintain a respectful and productive school environment. In addition, each teacher will develop a set of classroom responsibilities.

Throughout the school year children are reminded and encouraged to follow these codes in order to create a positive school climate.

Division Expectations

- Bullying, or abusing physically, sexually or psychologically, in any form by any individual is unacceptable. This includes cyber bullying.
- Gang involvement will not be tolerated on school property
- Students and staff must adhere to school and division policies respecting appropriate use of email and Internet. (see acceptable use guidelines in handbook)
- Discrimination is prohibited on grounds of race, religion, gender, age or sexual orientation.
- Using, possessing or being under the influence of alcohol or illicit drugs at school is unacceptable.
- Possession of weapons is prohibited on school grounds. (as in Sec. 2 or Criminal Code of Canada)
- In the event of disagreement with decisions made under this code of conduct parents may appeal to the principal, then to the superintendent, finally to the board of trustees.

Citizenship

At École Lansdowne School students are expected to:

1. Be on time for school and equipped with the necessary materials.
2. Do their best and be responsible for completing assignments and handing them in on time.
3. Be courteous and helpful to each other, to staff, and to visitors in the building.
4. Behave in a way that is respectful, responsible and allows everyone to be safe. Disagreements should be settled in a fair, non-violent way.
5. To move around the building in a quiet, orderly way.
6. Follow the school and individual classroom responsibilities.
7. Students are discouraged from bringing cell phones to school. If students bring a cell phone it is to be turned off and stored in their backpacks or lockers during school hours.

School Responsibilities

In order to maintain a healthy and productive learning environment all students must accept responsibility for their actions.

1. Respect yourself

- use polite language
- play safely
- dress appropriately for the school day

2. Respect others

- listen to the person who is speaking
- keep your hands and feet to yourself
- follow directions from all adults at school

3. Respect your school

- help keep your school clean
- practice good citizenship

The school responsibilities aim to ensure safety, responsibility and respect for all. Failure to follow these basic rules will result in the following consequences which are not always applied in the order in which they appear.

- **warning**
- **teacher/student conference**
- **teacher/student/principal conference**
- **phone call home by teacher or principal**

Consequences

The following is a list of consequences that may be used.

Behaviour report—to be completed at school and at home with parent(s)/guardian(s).

Removal from outdoor recess—cooling off and reflection period at which time an incident report may be completed.

Removal of privileges - student may not be allowed to participate in a special activity if safety concerns persist.

Individual student behaviour plan—initiated by the teacher for student who have ongoing difficulty in following school responsibilities.

Time out—a cooling off period of time to address a student's non compliant or disruptive behaviour
