ELECTIONS

The Winnipeg School Division Board of Trustees elected Trustee Mark Wasyliw as Chair and Trustee Sherri Rollins as Vice-Chair for the 2015/16 term.

SUPERINTENDENT'S REPORT NO. 11-2015

- In recognition for special accomplishment, authority was given for Ms Irene Okumura, teacher at King Edward School to receive funding in the amount of \$500 to support her participation in the Teachers Institute on Canadian Parliamentary Democracy in Ottawa, Canada from Feb. 21-26, 2016 and substitute costs for one teacher for up to five days.
- The proper officers of Winnipeg School Division (WSD) were authorized to enter into a an agreement with Konica Minolta Business Solutions Canada Ltd. To acquire photocopiers for the period Sept. 1, 2015 to Aug. 31, 2020 with an option to extend the agreement for two additional one year terms.
- The proper officers of WSD were authorized to enter into an agreement with Manitoba Children and Youth Opportunities MB4 Youth for funding in the amount of \$111,751 for the "Fresh Start" Program at Gordon Bell High School for the 2015/16 school year.
